ADDENDUM / CLARIFICATION

RFP No. : HF/HO/MKTG/2130 Dated: 17-08-2026: e-Tender for Sale of Apples under Market Intervention Scheme (MIS), 2026

With reference to the e-Tender Notice issued by HIMFED for sale of apples procured under the Market Intervention Scheme (MIS), 2026, and pursuant to the queries/clarifications sought by prospective bidders, the following clarifications/additions are hereby issued. These shall form an integral part of the Tender Document and shall be read in conjunction with the terms and conditions of the original tender.

1. BOQ – QUANTITY AND RATE

The bidder is required to quote **only the rate per Kg** in the BOQ.

The quantity mentioned in the tender, i.e. **5,000 MT**, is the **expected quantity** only. The actual quantity to be delivered/lifted shall be determined on the basis of the actual availability of apples under MIS 2026 and the quantity made available by HIMFED.

Accordingly, the bidder shall quote its **Basic Rate per Kg** in the BOQ, and no bidder is required to enter the actual quantity in the BOQ.

The final billing shall be made on the basis of the **actual quantity delivered/lifted**, duly supported by the official weighment/records of HIMFED.

2. PAYMENT OF TENDER FEE AND EMD THROUGH RTGS/NEFT

The Tender Fee of **₹2,500/- (Rupees Two Thousand Five Hundred only)** and EMD of **₹2,00,000/- (Rupees Two Lakh only)** may be deposited by the bidder through RTGS/NEFT in the bank account of HIMFED.

3. PERIOD FOR LIFTING/LOADING OF APPLES

The period for lifting/loading of apples under the tender shall be from:

Starting Date: with immediate effect

Closing Date: 31-10-2026 (As per MIS policy of HP Government)

The successful bidder shall lift the apples made available by HIMFED at **Parwanoo, District Solan**, during the above-mentioned period and in accordance with the daily quantity/dispatch schedule communicated by HIMFED.

The exact quantity available for lifting shall depend upon actual procurement and availability of apples under MIS 2026.

4. MAXIMUM DAILY LIFTING CAPACITY

The successful bidder has to lift the stock as per availability of stock and the dispatch schedule communicated by HIMFED. The bidder shall arrange sufficient vehicles, labour, and other logistics to lift the allocated quantity on a daily basis so as to avoid accumulation/backlog of sold stocks at the delivery point.

The actual daily quantity shall be based on the availability of apples, operational conditions and the dispatch schedule issued by HIMFED.

5. QUALITY / NON-ACCEPTANCE OF PARTICULAR CONSIGNMENT

The apples are being offered on “**As Is Where Is**” basis.

6. OTHER TERMS AND CONDITIONS

Except to the extent specifically modified/clarified above, **all other terms and conditions of the original Tender Document shall remain unchanged and shall continue to be applicable.**
